




# Consolidated Public Water Supply District No. 1

# Update

## Tank Inspections

Consolidated Public Water Supply District No. 1 was awarded a grant from the Mo. Department of Natural Resources for partial funding of Engineering Services for an update to the Master Plan. One component of the Master Plan Update involved tank inspections for three District water tanks. The Bethel, Route VV and Koch tanks were examined by underwater inspection (SCUBA) to determine the interior condition. Underwater inspections alleviated the necessity of the tank being taken out of service or drained. Preliminary results of these inspections indicated the Route VV and Bethel towers to be in good condition with minimal repairs needed while the Koch tower is in need of some repairs and will be slated for replacement in the near future. Final reports and recommendations will be received in the coming months.
