Meter Deposit Increase and Refund for Satisfactory Payment History

Effective January 1, 2023, meter deposit amounts will increase according to meter size per the following table.

Meter Size	Deposit Amount
5/8 x 3/4	\$100.00
1-inch	\$200.00
1.5-inch	\$400.00
2-inch	\$1,200.00
3-inch	\$1,200.00
4-inch	\$1,200.00
6-inch	\$1,500.00

Meter deposits are designed to cover the final bill for a location, which is often more than the amount of a single monthly bill. Current deposit rates have been in effect since July 2002 and have not kept up with increases to the base rate and/or water rates over the past 20 years. The new rates have been formulated to cover a two-month bill based on a recent average of 12 months of billing history for each meter size.

In addition, the District will begin refunding meter deposits held for customers who have shown a satisfactory payment history. Satisfactory payment history is defined as no more than two (2) past due payment penalties over 18 consecutive months and no locks for non-payment during the same period.

Capital Improvement Projects help ensure that we maintain enough capacity to meet water needs. Below are a few of the Capital Improvement Projects the District has planned for 2023.

Project Estimated Cost

New Salem Road Upgrade:

\$500,000.00

5,800' of 12" PVC from Robbie Forbis Road to Rangeline Road

Estimated Completion Summer 2023

Route J Upgrade Graham RD to Woodlandville:

\$1,550,000.00

22,000' of 12" PVC from the intersection of Graham RD and Booth Lane then north along the west side of Route J to Woodlandville Water Tower

Estimated Completion Fall 2023

Route E 12" Waterline Upgrade:

\$720,000.00

Upgrading approximately 5,600' of existing waterline with 12" waterline Route E from the Fire Station to Wilcox Road
